## WEDDING GUIDELINES

.To assist the clergy in getting to know you, all couples seeking to be married at St. Mary's will engage in a series of premarital counseling conversations with the rector or other clergy person. These sessions will explore the sacramental nature of marriage, plan the wedding liturgy, and discuss relationship dynamics to support a healthy marriage. Please plan on five conversations, or more if necessary. Under certain circumstances, and only with the invitation of the rector, guest officiants may solemnize a marriage at St. Mary's. At least one of the persons seeking marriage must be a baptized Christian.The guidelines for marriage between people of the same sex are the same as for people of the opposite sex. The Episcopal Church requires a minimum of thirty days notice before a marriage can take place, and we prefer at least six months to ensure adequate preparation with the couple. If one or both of the persons is divorced, the clergy must obtain permission from the Bishop of Massachusetts. Please allow adequate time to work through this process.

## Rehearsal

A wedding rehearsal is required, no more than 5 days in advance of the wedding. It is essential that all members of the wedding party are present. Please schedule the rehearsal at the time that you schedule your wedding.

## **PLANNING THE SERVICE**

## The Liturgy

The form for THE CELEBRATION AND BLESSING OF A MARRIAGE begins on page 422 of The Book of Common Prayer. This service offers a framework for creating a marriage liturgy that honors the rich traditions of the Episcopal Church and the unique qualities of the bride and groom. In addition to prayers, vows, and blessings, the wedding service may include several hymns, readings from Scripture, other sacred and appropriate readings, a short homily, and Holy Communion - if desired. All persons are welcome to receive Holy Communion at St. Mary's. A clear invitation is issued during the service so all feel welcome at the Lord's table as well as instructions on how to receive Communion. The officiant will work with you to shape a beautiful and meaningful service.

If the wedding liturgy does not include Holy Communion, it will take approximately 30 minutes. If the ceremony includes Holy Communion, depending on the number of guests, it will take 50 - 60 minutes. A maximum of three hours is allowed for each wedding. Wedding parties may arrive up to two hours in advance of the Liturgy and remain for up to one hour following it for photographs.

## Music

Music is an integral part of festive church liturgies. A church wedding is primarily a community affair, not a private or personal rite. Wedding music should be chosen to reflect the Christian understanding of marriage as an expression of God's love. Hence, the overall effect and theological implications of the words and music you select are an extremely important part of your premarital plans and discussions. The selection of all music is done in consultation with the officiant and Minister of Music. The Minister of Music will be happy to provide you with an ample list of music from which you may choose. He is also happy to play samples of the pieces at your consultation. Please consider using popular, secular music at the rehearsal dinner or reception rather than as part of the liturgy. In addition to the organ, the Minister of Music may approve the presence of a soloist and other instrumentalists. Please do not engage additional musicians until you have talked with the Minister of Music. Additional rehearsals may be necessary and if so the couple will be responsible for paying those fees.

After confirming your date with the rector, please contact the Minister of Music, Dr. Mark Lawlor, at least three months prior to the date of your wedding in order to schedule a consultation. He can be reached at music@stmarys-church.org.

#### Witnesses

The minimum number of persons required at a wedding is five (5): the Officiant, bride, groom, and two witnesses. The same individuals will sign the parish register following the marriage service.

#### **Marriage License**

A Marriage License must be obtained from the proper civil authorities. Please bring your marriage license and any balance due on your fees to the parish administrator on the day of your rehearsal. We do not conduct a rehearsal without these items in place. The Officiant will sign the marriage license and return it to the issuing county after the service.

#### **Flowers**

The focal point of the church is the altar, and here the couple exchanges their vows. This elegant and simple setting does not require elaborate decoration. The use of candles is restricted to those currently in the church. The flowers at the altar must fit on the tables behind the altar. Flower delivery time must be arranged in consultation with the church office. Wedding flowers are considered gifts to the church and will remain in the church for use the following Sunday. No rose petals, rice or birdseed are permitted.

#### Photography

A wedding is a worship service at which two people marry each other before God. Our policies in regard to photographers and videographers are designed to protect the reverence of the marriage ceremony. Flash photography is not permitted by guests or professionals. The wedding photographer may take a limited number of pictures from the congregation, but s/he may not enter the altar platform. We will gladly pose for any pictures to recreate scenes from the liturgy following the service. A video camera may be set up in an unobtrusive location but may not be manipulated or moved during the service. The rector must approve the placement of the video camera. Outdoor photography may be done at anytime, weather permitting. It is very helpful for the photographer to have a clear agreement with the couple as to what photos are desired. It is the couple's responsibility to inform the photographer of these policies. Please do not ask for any exceptions to these policies, which are designed to protect our traditions and sacred space as well as the dignity of the bridal party.

#### **Seating Capacity**

The church can seat 225 people. There are 16 pews on one side and 15 pews on the other. There are 16 pew candles, if desired.

## **RECEPTION GUIDELINES**

The Parish Hall is available for wedding receptions and may be engaged when your application to be married at St. Mary is accepted. Wine and champagne may be served by a TIPS certified bartender. Music and dancing are permitted, as long as you respect the 10 pm curfew for our residential neighborhood. You and your caterer are responsible for returning the hall and kitchen to its original condition. If you desire the services of our custodian, at least 30 days notice is required. To reserve the hall, a signed contract and deposit are required.

## **Reception fees**

\$500 for 3 hours usage (\$250 for active, pledging members for at least 2 years)

\$150 per additional hour needed, including set-up and clean-up time

The church's custodian may be employed at a rate of \$25 / hour to assist with set-up and clean-up. The church needs a minimum of one month's notice to arrange for these services.
